TO: Nicholas Sigmund, Senior Zoning Officer (nsigmund@co.walworth.wi.us)
RE: Potential zoning ordinance amendment for "one-time events"

The Town Board reviewed the information at the Board meeting on April 20, 2022 and discussed the potential zoning amendment.

Discussion points the Town Board referred to:

- Issues that could arise due to the size, location, and what applicant might consider a one-time event length (day, weekend, three [3] days)
- The Town doesn't have any enforcement authority for safety and/or traffic issues, as well as noise and trash – they rely on the Walworth County Sheriff's Department. And without going through the regular procedure in place now could cause undue reliance on them (not having been involved in the permitting process) and full knowledge of the event
- A one-time event could go so well, applicants may not realize that the rules would change for the following years

The Town Board unanimously is NOT IN SUPPORT of an ordinance amendment for Town issued permits for these events.
