7. Resolution 26-06/21 Authorizing the Capital Project for Purchase of a Public Health Mobile Medical Clinic with American Rescue Plan Funds

Acting Director of Health and Human Services Carlo Nevicosi stated that Health and Human Services (HHS) is requesting authorization to purchase a mobile clinic in order to increase access of the COVID-19 vaccine to the public. Nevicosi cited that Walworth County has a lower vaccine acceptance rate as compared to other counties statewide and mobile clinics are one strategy that has been used all over the world to target underserved areas. A mobile clinic will provide for countless opportunities to capture more of the population; including attending outdoor events over the summer months. This one-time purchase will provide the county with a resource for the next 10 years and utility well beyond the COVID-19 pandemic. Chair Grant offered a motion, second by Supervisor Ingersoll, to approve Resolution 26-06/21. Discussion ensued relative to whether a local vender had been vetted, where the vehicle will be kept, and what other counties in Wisconsin, comparable in population, have a vehicle of this type.
